Whereas, in the opinion of the State Government, the following area in District Bareilly in Uttar Pradesh requires to be developed according to plan :

Now, therefore, in exercise of the powers under Section 3 of the Uttar Pradesh Urban Planning and Development Act, 1973 (President's Act No. 11 of 1973, as re-enacted by U. P. Act No. 30 of 1974), the Governor is pleased to declare, with effect from the date of publication of this notification in the Gazette, the following area to be a development area :

#### Bareilly Development Area

Area included in Bareilly Regulated Area, notified under sub-section (1) of Section 3 of the Uttar Pradesh (Regulation of Building Operations) Act, 1958 U. P. Act XXXIV of 1958), under Government Notification No 4190-K/37-87-NKV-71, dated November 1, 1971, excluding Cantonment areas and lands owned, requisitioned or taken on lease by the Central Government for purpose of any naval, military or air force authority.
